NCRnet

The NCRnet Applications and Operations teams have been investigating options for migrating WebEOC for use over the NCRnet. The goal is to increase continuity of operations by using NCRnet while minimizing the need for multiple URLs to access WebEOC.

The current implementation plan is setup into phases. The first phase is just to transfer the NCR WebEOC Fusion server access to the NCRNet and have the WebEOC systems connect through it. Once the migration starts, the plan is to be completed within six weeks. The exact dates for cutovers are being determined and will be shared when known.

During the actual cutover representatives from your network staff and you will be needed for configuration, testing and troubleshooting.

Report from the NCR WebEOC Subcommittee

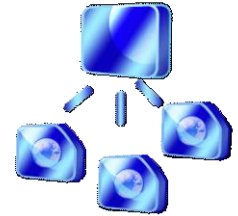

Special WebEOC Administrator Note

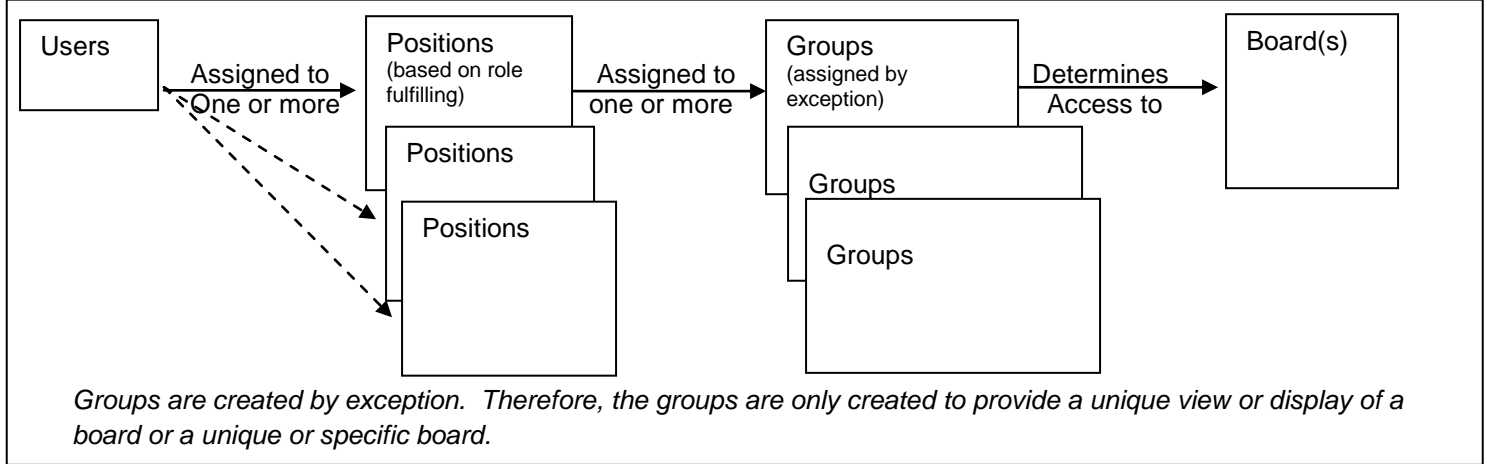
Reported by:

Whenever you access a board's input view as an administrator you will see the "Reported by" field. It is just because you have full administrative rights. Others will not see this field.

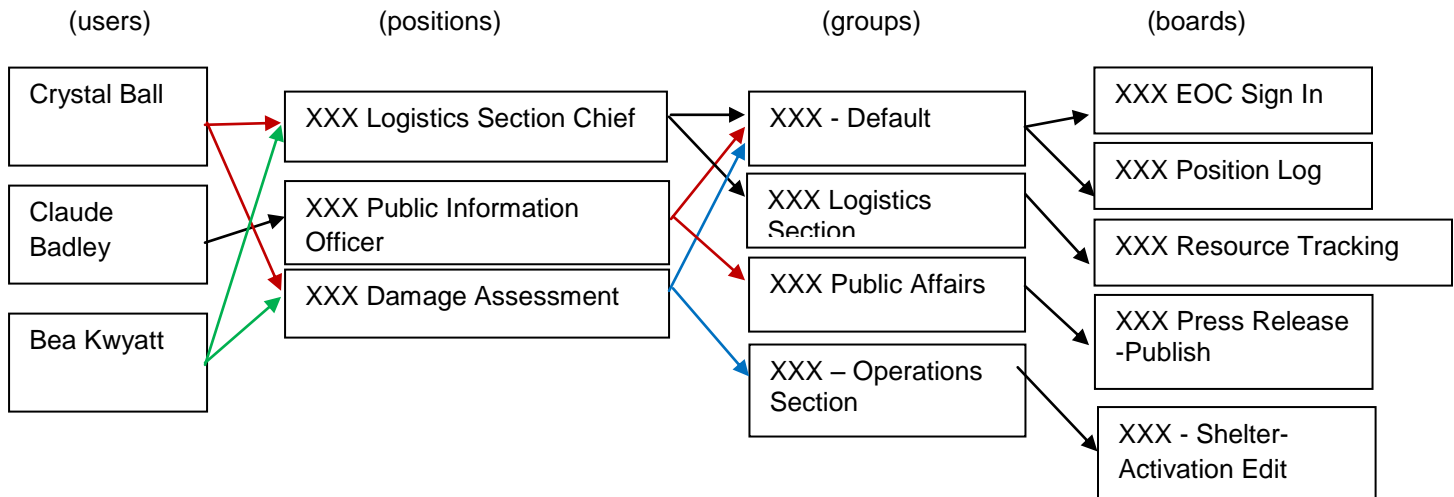

Assigning Boards

The following diagram shows the path way for assigning a aboard to a user.



Example:



Example Explanation:

- Two of the users in the example above can log into one of two positions that they have been given permission to fulfill. One User has only one position option.
- Of the three listed Positions, all three are in the XXX – Default group and have access to the boards assigned to that group.
- Only the XXX Public Information Officer group would have access to the XXX Public Affairs group. This group provides access to the Press Release board (Publish view).
- Using the Claude Badley example: Claude is assigned to work the XXX Public Information Officer position. This position is assigned to the XXX – Default group and the XXX Public Affairs Group. Therefore the boards this person would see are:
 - XXX EOC Sign In board (from the XXX - Default group)
 - XXX Position Log (from the XXX - Default group)
 - XXX Press Release – Publish (from the XXX Public Affairs group)

Steps for setting up Groups

- Determine what board views/access needs to be assigned
- If the board is county wide oriented, meaning every user should have access to view or input into this board, assign to the Default group
- If the board is County wide oriented but only a handful of users should have privileges to modify or add data, assign their specific views to the group that represents these privileges. If there is not a group present, one may need to be created.
