

# Supported Specialty WebEOC Boards

## Medical Facility Status Tracking (Version 1.0) Incident Independent

**Description:** This board captures Medical Facility Information and status data for power, water and telephone.

**Views:** There are three list views for this board. One for the administrator to create medical facility records; one for the facility user to update the status information; and one with view only capabilities.

**List View** – This is the administrator’s list view. That provides additional privileges than the facility user or read only user.

- *Edit* button to modify the corresponding facility record. (Not available on the view only display)
- *Search capability* on the Facility Name and Address
- *Sort capability* on the Facility Type, Name and Address fields by clicking the column header.
- *Print to PDF* button to show the information without the various buttons and provide a printable view.
- *Checks* to quickly identify fields that indicate checked equals “Yes” and no check equals “No.”
- Color coded status fields to quickly identify items that have an issue. Yellow indicates a minor issue; Red indicates an issue to address.
